I give unto my son Richd. Blunt the sum of two hundred dollars, together
with all negro's Stock of all kinds, plantation utensils household furniture,
etc. &c. which I have already delivered to him and the now in his possession,
all which I give unto him and his heirs
I give unto my son Benj. Blunt, the tract of land that I purchased
of Micajah Pope, Containing One hundred and fifty Acres, and the tract
of land that I purchased of Howell Vaughan, Containing two hundred
and eighty acres, and the tract of land that I purchased of Eliakim King
Containing one hundred & two Acres, and also the tract of land that I
purchased of Moses Johnson, Containing twenty three Acres, and at time of
death I give unto him the tract of land wherein I now live Containing
one hundred and thirty five Acres, I also give unto him eleven negroes namely
Apid, Hounds, Suckey, Henry, Jack, Epsen, Dicks, Beckey, Tom, and Fanny
an' Amos, to go with them increase from the date hereof, all which I give
unto my s^r son Benj and to his heirs forever, I also give unto my s^r son Benj.
my Bedf^r young man, and my girl Watch
I leave unto my beloved wife Francis Blunt, during her natural life, those
of the land and plantation whereon I now live Containing four hundred
and thirty seven Acres, and the tract of land that I purchased of Howell
Vaughan Containing 860 Acres also the following negroes namely
Dale, Ned, also Pat Ephraim, Dick, Sharpe, Sarah Nancy, Nelly, Phattie,
Nelly Phagan, George, Castor, Rose, Titus, David, Mary, Sam, Coats,
Anny Mariah Celia, Flouller, and Dolly, together with their increase
from the date hereof, and also all the remainder of my Stock of Horses, Cattle,
Sheep and Dogs, all my house hold and Kitchen Utensil to gether with
the whole of the Remainder of my estate, and I do hereby direct and give
unto my s^r wife Francis full power to dispose of all and every part of
the personal Estate hereby left to her (Leaves Excepted) in such manner
that she think to proper, but upon the Condition that she bequeath her
gifts, or Leases, amongst my Children or their descendants

my wifes death in the following manner (viz.) begining on the lotto meadowland
44 rods below the upper end of Spinches line by the 2^d branch three aitlength
line arod the land into the poleg branch, so as to divide the 2^d part into
Lots of equal number of acres, that part of the lying below the line of loto
line to be given to John Peeter & his heirs.
