I constitute and appoint my son Bennett Taylor executor of this my last will hereby revoking all other by me heretofore made & direct that he take an Inventory of all my Estate but that there be no appraisement made thereof — This will is written wholly with my own hand, Signed & Sealed this Seventh day of January 1805
