 and Anne Denson in equal proportion: all my plantations
 and Lands, and all my other estate both real personal or
 mixt whether in possession Remainder or Reversion to them
 and their heirs forever, Lastly, I hereby constitute and appoint my
 Brother Joseph Denson and my daughter Mary Denson my executor
 and executrix to this my last will and Testament Reading and
 making Void all other Wills heretofore made, In Witness whereof he
 the said Jordan Denson hath hereunto set his hand and affixed
 his seal this 31st day of July 1806
