 This will was presented in Court for the Oath of two of the Subscribing witnesses thereof and ordered to be recorded. — and at Court held for the County aforesaid on the 21st day of March 1844 On the Motion of J^{es} Potts for Administration with the will annexed of said John Cotton and Thomas Phillimore one of the Executors therein named refusing to take upon himself the burthen of the Execution thereof and it appearing to the Satisfaction of the Court that Duery Cotton the other Executor named in the will is not an inhabitant of this County wealth, Therefore Administration with the will annexed of said John Cotton (decd) is in due form of law granted unto said J^{es} Potts on his giving bond and security whereupon &c. — and at Court held for the County aforesaid the 20th day of June 1844 Duery Cotton one of the Executors named in the will of John Cotton and appearing in Court and applying for probat thereof and J^{es} Potts to whom Court with the will annexed hath been heretofore granted on said estate also appearing and surrendering his letters of Administration, Therefore probat of the said will is granted to the said Duery on his giving bond and security whereupon &c.
