natural life or widowhood, for to raise and school my children upon
and after her death or marriage my will and desire is that my
Executor sell my whole Estate both real and personal for the best prices
that can be got, And the money arising to be equally divided
amongst my five Daughters Right, Lister, Lucy, Dianna, Solberg and
Patty Hart or their survivors of them and their heirs forever.
And I do hereby empower my Executor to make sufficient deed or deeds
for conveying my land as by law shall be deemed sufficient,
I likewise constitute and appoint my wife Sally Hart and Jordan
Hart my whole and sole Executor of this my last will and testament,
revoking, disannulling and making void all and every other former
will theretofore by me made, Do witness whereof I have hereunto
set my hand and sealed this nineteenth day of April one
thousand Eight hundred & fifteen—
