We the undersigned arbitrators mutually chosen by Rice P Pierce John Pierce  
 and Nathaniel Pierce heirs and Legates of Elizabeth Pierce dec'd under  
 and select of Rice P Pierce dec'd of the one part and Benjamin Cobb  
 Administrator of Robert Curwys dec'd who was the administrator of the  
 said Elizabeth Pierce dec'd of the other part to settle & adjust and finally  
 determine all matters in difference between the parties in relation to the  
 administration of the said Robert Curwys on the estate of the said  
 Elizabeth Pierce dec'd and whereas for the putting an end to the  
 said differences and disputes that the Rice P Pierce & Nathaniel  
 Pierce and Benjamin Cobb by their several bonds or obligations bearing  
 ing date the day of 1819 are reciprocally bound each to  
 the other on the penal sum of to stand to and abide  
 the final determination of us Colten Kitchen John Siffins and Jeremiah  
 Cobb arbitrators indifferently chosen between the said parties. Have  
 this day taking the matters and things in difference between the said  
 parties under our consideration and having had due deliberation thereon the  
 testimony of the parties having been submitted to us do award and determine as follows  
 that the said Benjamin Cobb owes of Robt Curwys dec'd pay to the said Rice P  
 Pierce and Nathaniel Pierce their proportion of the estate of the said Elizabeth  
 Pierce dec'd amounting to the sum of one hundred and eighty one dollars & 4/10  
 cash (by reference to the annexed account it will appear fully with interest  
 thereon from December 31/1819 till paid Given under our hands and seals the  
 21st day of July 1820
