changed with the payment of their demands. Sales do us that any debt due Mary Vaughan Tomant
be paid out of the same fund

The bed and furniture left my wife. I gave to my Grand Daughter Sally Edwards after her death and after
 Esau I gave my Carpenter tools the two trunks and gave them to my Grandson John for Europe.

I desire that old Rose be supported during his life by my wife and that she keep my negro woman Sherry with her youngest child Barbary so long as said woman Rose may live. I also desire my wife to send my son such maintenance as he is entitled to from me

To My Mother's children by my bro. Sons John and Vincent Edwards not by including them now as
Kings but those which they may hereafter have. I give and bequeath immediately after my death
my Slave Watson Hannah Nod and Ched and after the death of John I give them my negro woman
Chancy and Choo Partay and any increase they may have from that time and after the death of
my wife I give I leave that my particular friends Jordan Edwards and William Edwards
should in this behalf act as Guardians to my said Grand children and they are hereby authorized
to make sale of all or any part of same property when and where they see fit and they are hereby authorized
and apply the money to the use and education of my said children.

Spent and bequeath unto my Sons, Tyler and, Edmund, Edward's one dollar each. Having formerly made provisions for them by giving each of them a tract of land

the half of my Stock in cattle, hogs and sheep. I leave in the hands of my Executors for the payment of my debts, should that provision prove insufficient, then I leave the negroes given to my Son and children to the charge of, with the payment of such debts as may stand out unpaid excepting such debts as I have directed to be paid by a different fund.

This Will was presented in Court by Elizabeth Edwards the executrix therein named proved by the oath of H^{on} Sadrer Smith Esq and James D'Almeida Esq the witnesses thereto and ordered to be recorded and on the motion of said Executrix who made oath according to law Certificate is granted here for probat. thereof and an Inq on his jury land and tenancy whereupon the said Elizabeth Edwards together with William Melrose Esq and L. Parsons and James Murphy her securities entered into and acknowledged their bond in the privacy of Ten Chancery and do stand Conditioned as the law directs

Selig Stephen William West Esq. 13. Ryeview John West and Charles West to them and their heirs forever Lastly I nominate and appoint Barnett Barnes and
