In the name of God Amen I Tabitha Foster of the County of Southampton and State of Virginia being in good health at this time and
 sound mind and memory thanks be to God for his mercies do make and ordain this my last Will and Testament in manner following
 First of all I desire that all my debts and funeral charges be paid and discharged

I give to my son John James his negro boys Peter and George

I give to my daughter Tabitha Foster one negro woman Lucy and her increase to her and her heirs forever

I give to my Grandson James Johnson the son of Tabitha Foster one negro boy named Chaff to him and his heirs forever
 Lastly I nominate and appoint my friend Matthew Gardner my whole and sole executor to this my last Will and
 Testament at writing and signing. Thus at my hand and close the 16th day of March 1819

Tabitha Foster (Sd)

A Court held for the County of Southampton the day February 1823. The Incumbent
 presented on behalf by Matthew Gardner the executor named who refused to take a poor him as for
 the burden of the execution thereof proved by the oath of Lawrence Gardner and Nicola Bradshaw
 two of the witnesses there and ordered to be recorded. And on the motion of Tabitha Foster for letters
 of administration with the will annexed the same is granted her on her giving bond of security
 whereupon she said Tabitha Foster together with Matthew Gardner her security entered into
 and acknowledged their bond in the penalty of five thousand dollars conditioned as the
 Law directs
