In the name of God amen I Willm Jordan of the County of Southampton and in the State of Virginia being law and order of body but of a sound and disposing mind and memory do make and declare this of my last will and testament in the unanimous form following to wit

Item

I give and bequeath unto my wife Rhoda all and every part of my estate after paying all my just debts to her and her heirs forever. I also do hereby nominate, constitute and appoint Samuel E. Green my whole and sole executor to this my last will and testament hereby writing and discharging all other wills, testaments hereafter by me made or to be made. I Willm Jordan with my own hand and affixed my just this fourth day of October 1823 signed sealed published and declared to be my last will and testament in presence of

At a bond held for the County of Southampton on the day of October 1823. This will was presented in Court by Samuel E. Green the Executor therein named who refusing to take upon himself the burden of the estate thereof proved by the oath of Willm Ferguson Jr and John Whitfield Two of the witnesses thereto and ordered to be recorded and on the motion of Rhoda Jordan for an administration with the will annexed the same is granted her on her giving bond and security whereupon the said Rhoda Jordan together with James Kirk and John Ferguson her sureties entered into and acknowledged before me in the presence of five hundred dollars conditioned as the Law directs.
