

I give and bequeath unto my four daughters equally after the death of dies on the day aforesaid. Dorothy Gray
and Katherine, Elizabeth and Anna Maria and my wife and by the name of Thomas Farmer I bind Estate
give to each of them one ninth part of my personal Estate which may remain after our Master has had
his proportion to them and their heirs forever But should either of them die under age or without lawful
issue my will is that their proportion descend to their issue living issue of the whole. Also but should they
die also without issue under age my wish and desire is that their proportion descend to their Brother
Joseph & his heirs and his heirs, Also give to my four daughters their right to live in the
Farmers House and farm land and farm My wife and desire that my wife is Executive my first
Youngest Child in trust of the Estate which I have left to her (Item) I give and bequeath unto the
heirs of Benjamin Hale one dollar each to them and their heirs forever Item I give and
bequeath unto the heirs of Abby Hale one dollar each to them and their heirs forever
I give and bequeath unto my son John Rock the lands he has a due for also one hundred dollars
to be received from my Estate two years after this will is admitted to record to him and his heirs forever
Item I give and bequeath unto my son James Rock the land he has a due for also one hundred dollars to
be received from my Estate at the end of two years after this will is admitted to record to him and his heirs forever
Item I give and bequeath unto my son John Rock the land he has a due for
also two hundred dollars to be received out of my Estate at the end of two years after this will
is admitted to record to him and his heirs forever Item I give and bequeath unto my son Edson
in Rock the land he has a due for to him and his heirs forever (Item) My wife and
desire that my Executrix do sell the following tract of land the first tract that I purchased
of Thomas Farmer and the other tract near the Mill also all the remainder of my Estate
not before disposed of by me of every kind whatsoever leaving paying my just debts also to him and
some negroes such as are not easily contrived for the same purpose of required Secuity. I do
hereby nominate and appoint my friend Benjamin Clegg as my male and
wife Executrix to this my last will and testament revoking all other former Wills by me

said Executrix who made oath according to law certified as granted him for obtaining a picture
at his request for me in his young days and Secuity whereupon the said Benjamin Clegg
together with Carl Bonner and Allen Edwards his Deputies entered into and made a bond in the
sum of ten thousand dollars Conditioned as the law directs

I Lewis Williams of Loudoun County and State of Virginia make this my last will and
testament in manner and form as follows. I bind unto my son Peter Williams during his
natural life the following negroes to wit Robt and William and Eddie and my slave for being an
idiot I appoint my son Richard Williams and Matthew Williams his Guardians to take care
of them and manage his property for his support without being bound to any bonds or security

I give and bequeath unto my Daughter Dora Cobb the following negroes Donor Cobb to her
and her heirs forever (Item) I give and bequeath unto my Son Richard Williams on half of my
tract of land wherein Peter and the following negroes Peter Henry and Elijah to him and
his heirs forever (Item) I give and bequeath unto my Daughter Martha Hancock ten dollars in
addition to what I have advanced her before (Item) I give and bequeath unto my daughter Sarah
Washington ten dollars in addition to what I have advanced her before advanced her

I give and bequeath unto my Son Matthew Williams the other half of my Land and half of my
Bequeath also the following negroes Lucy, Mangy, Peter and all my other slaves to him and his heirs forever

I give and bequeath unto my Grandson Sam or Cobb the following negroes his old master
the slave Peter & his wife to him and his heirs forever
