

I give and bequeath unto my four daughter equally after the death of three in the day Margaret Dorothy Mary and Katherine. Each all my lands sales and thereafter and by the names of William Thomas John Sater give to each of them one fourth part of my personal estate which may remain after their Mother has received her proportion to them and their heirs forever But should either of them die under age and without issue after my will is that their proportion descend to their then living sisters of the whole this but should they all die without issue under a year my will and desire is that their proportion descend to their Mother Joseph I bequeath to him and his heirs, Sater give to my four daughters their sing to live in the Mansion House Lane ten sh. 6p. Item My will and desire that my wife do educate my four youngest Children out of the estate which I have bequeath to her (Shew) I give and bequeath unto the heirs of Benjamin Fiske one dollar each to them and their heirs forever Item I give and bequeath unto the heirs of Peter Fisk one dollar each to them and their heirs forever

I give and bequeath unto my son Sater both the house he had adored for Sater give to him one hundred dollars to be raised out of my estate five years after this will is admitted to record to him and his heirs forever

I give and bequeath unto my son Daniel both the land he has a due for also one hundred dollars to be raised out of my estate at the end of three years after this will is admitted to record to him the heirs forever (Shew) I give and bequeath unto my son John both the land he has a due for also one hundred dollars to be raised out of my estate at the end of four years after this will is admitted to record to him and his heirs forever Item, I give and bequeath unto my son Ebenezer both the land he has a due for to him and his heirs forever (Shew) My will and desire is that my executor do sell the following tracts of land the first two tracts that I purchased of Thomas Feller and the second tract near the mill also all the remainder of my estate not before disposed of or of every kind whatsoever towards paying my just debts due to him and some negroes such as are not easily converted for the same purpose of requiring security. I do hereby nominate executor and appoint my friend Benjamin Croffier as my whole and sole executor to show my last will and testament out writing all other former wills by me made null and void whereof I have hereunto set my hand and affixed my seal this 23rd day of August 1725 signed sealed and attested

I give and bequeath unto my Daughter Dora both the following negroes Dances Belia to her and her heirs forever (2nd) I give and bequeath unto my son Richard Williams on half of my tract of land whereon Sater and the following negroes Peter Henry and Edley to him and his heirs forever (3rd) I give and bequeath unto my Daughter Martha Hancock ten dollars or all more or what I have advanced her here for (4th) I give and bequeath unto my daughter Sarah Washington ten dollars in addition to what I have advanced her here for advanced her

I give and bequeath unto my son Matthew Williams the other half of my land and half of my bequeath also the following negroes Amy George Peter and Abby and what I have advanced to him and his heirs forever

I give and bequeath unto my Grandson Sater both the following negroes Ben and Abner and what I have advanced to him and his heirs forever
