In the name of God amen I Samuel Doles of Southampton County and State of Virginia being weak in body but in perfect mind and memory thanks to Almighty God for the same do make and ordain this writing to be my last will & testament in the manner and form following Viz in the first place it is my will & desire that my Executors who I shall hereafter name pay all my just debts which I may have contracted as soon as convenient out of my Estate 2^d I give and bequeath to my loving mother Elizabeth Doles all the money which she is indebted to me on mill what she owes me personally as what she owes my Executors for me to her & her heirs forever 3^d I lend to my said Mother Elizabeth Doles during her natural life all the settled property of every description not heretofore given away and after her death it is my will & desire that all my Estate be lent to my said Mother be divided into four equal parts one part of which I give and bequeath unto my Brother Francis Doles to him and his heirs forever I give and bequeath One third part of my Estate to my Sister Eliza Sumner to her and her heirs forever I give and bequeath one other part to my Sister Rebecca Doles to her and her heirs forever and the fourth and last part I give and bequeath to my niece Elizabeth My nephew Arthur Doles daughter & son of my brother David Doles to them and their heirs forever I hereby do state and appoint my Mother Elizabeth Doles Executor to this my last will and testament receiving all other debts by me heretofore made In witness whereof I have hereunto set my hand and seal this 2^d August 1825 signed sealed published &
